Notes:

- (A) Payment must be received by 30th of November 2018 in order to pay the amount reflected under “Annual fees”. This annual amount recognises the benefit the School receives from receiving payments in advance by being able to invest surplus cash.
- (B) Payment must be received by 31st of January 2019 in order to pay the amount reflected under “Annual fees”. This annual amount recognises the benefit the School receives from receiving payments in advance by being able to invest surplus cash.
- If payment is not received by 30th of November 2018 or 31st of January 2019 then the monthly instalment option becomes applicable.
- These amounts do not include the discounts allowed for siblings.
- The amenities and stationery levies are charged separately from fees and are not included in the amounts above.

Sibling discounts

The following sibling discounts apply:

- 1st sibling, 7.5%
- 2nd sibling, 15%
- 3rd sibling, 50%
- The above apply only to school fees and where siblings are concurrently enrolled.

Amenities Levy

The amenities levy is R4 266. This levy covers the funding of various items including, excursions, some worksheet printing, the school magazine and IT software. Includes PA Levy of R554 p.a.

Stationery Levy

The stationery levy covers the cost of stationery for the classroom such as exercise books, certain textbooks and workbooks and an allowance for art activities. This levy varies according to grade from R137 to R149 per month.

Learner-specific costs

While Grayston attempts to keep charges other than the above fees and levies to a minimum, please note that there may be other learner-specific costs applicable to your child. These costs, other than stationery requirements specific to your child's grade, are mainly optional and include aftercare, extra lessons, class TLC funds, photographs and senior prep camps.

Payment of fees

All fees are payable **in advance** either annually or monthly over a period of eleven months from January to November. Due to security considerations, the school does not accept cash payments for school fees. Cash payments must be made directly at any First National Bank branch. Our preferred method of payment is Electronic Funds Transfer (EFT) or if the account is paid monthly, debit order.
